Questioner: The Hon R M Clinton

Can the Government please provide a breakdown of where and how all the monies deposited in the Gibraltar Savings Bank have been invested and the rate of return on each of these investments as at 30 April 2023 and 30 September 2023?

ANSWER

The average yield in respect of the different categories of investment vehicles held by the Savings Bank Fund for the month of April 2023 is as follows:-

On-call accounts with the Bank of New York, Bank of England, Barclays Bank and Gibraltar Banks had an average yield of around 4.12%. The Gibraltar Banks were National Westminster Bank, Trusted Novus Bank, Gibraltar International Bank, Kleinwort Hambros Bank and MoneyCorp Bank.

Floating Rates Notes and other Fixed Interest Notes quoted on the London Stock Exchange had an average yield of around 5.58%. Can a detailed breakdown of the intended functions of each of the ambulances within the GHA's ambulance fleet be provided?

ANSWER

The High Dependency Unit (HDU) ambulance plays a critical role in facilitating tertiary cross-border transfers from a wide range of SBH facilities, including ICU, maternity rainbow ward, and cardiology units. To fulfil its mission effectively, this ambulance is designed with the capability to securely dock and stow all necessary equipment, provide reliable energy/voltage for extended durations, stock essential gases, offer an ergonomic and patient-friendly interior, and be powered by a suitable engine for efficient mobility.

Our frontline ambulances must be versatile enough to respond to a wide range of emergencies, whether they are medical or trauma-related. They should also be capable of navigating our narrow roads and facilitating cross-border transfers, particularly to catheterisation laboratories for percutaneous coronary interventions.

Patient transport ambulances play a vital role in providing transportation for both wheelchair-bound patients and ambulatory patients who require low-level escorted transport. These ambulances should feature incorporated wheelchair lifts, wheelchair docking systems, patient handling equipment, and the necessary medical gas supplies.
