The functions of the Council are-

- (a) to make its views known to the Minister on how to promote and secure the conservation, protection and enhancement of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (b) to foster understanding and facilitate the enjoyment of Gibraltar's heritage, antiquities or objects of interest, monuments or buildings, and historical conservation and archaeological areas;
- (c) to advise on anything which is to be done in relation to antiquities or objects of interest, monuments or buildings or historical conservation and archaeological areas, including advice that such activity always be carried out in a sustainable manner by a suitably qualified person; and
- (d) to identify present and future issues which require or may require addressing in relation to heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas.
- (2) The Council shall advise the Minister on matters relating to heritage, antiquities or objects of interest, monuments or buildings, historical conservation and archaeological areas it wishes to or which the Minister may refer to the Council.

Council to take account of certain matters.

- 8. It shall be the duty of the Council, in carrying out its functions under section 7(1) and (2), to take account, as may be appropriate, of—
 - (a) actual or possible ecological and other environmental changes affecting heritage, antiquities or objects of interest, monuments or buildings and historical conservation and archaeological areas;
 - (b) the need for social, cultural and economic changes in Gibraltar;
 - (c) the interests of the community in general.

HAAC Meetings and Collaboration

The Heritage and Antiquities Advisory Council (HAAC) held four meetings in 2024, achieving significant milestones in collaboration with the Ministry for Heritage and key stakeholders. Internal meetings with stakeholders, NGOs, and private developers, as well as regular consultations with the Minister for Heritage, ensured a comprehensive approach to heritage preservation.

Key Achievements in 2024

1. Archaeological and Restoration Projects

- Restoration of lesser-known heritage assets, including:
 - Sikorski Memorial
 - MOT WWII Bunker
 - Sally Port at Landport Tunnel
 - Southport Gates Sentry Guard Post
- Completed restoration of the American War Memorial and the Outer Wall of the Moorish Castle Complex along Road to the Lines.
- Ongoing restoration efforts at:
 - WWII Tunnels
 - Tower of Homage
 - 19th Century Prison within the Moorish Castle Complex
 - Northern Defences

2. Heritage Promotion and Intangible Assets

- Promoted Gibraltar's intangible heritage by developing ceramic Gibraltarian street names to celebrate language, legacy, and historical memory.
- Collaborated with Multilingual Gibraltar to protect and promote local languages.
- Participated in the 2nd Gibraltar International Conference (GIC2) at the University of Vigo, focusing on intangible heritage, identity, and language.
- Continued efforts to extend the UNESCO Convention on Intangible Heritage to Gibraltar.

3. Interpretation and Memorials

- Finalized and designed new interpretation panels for sites such as Europa Point, Landport, Waterport Gate, the Convent, the Cathedral of Saint Mary the Crowned and the Frontier.
- o Developed and designed memorials for significant historical figures.
- Collaborated with former members of HMS Calpe to memorialize their contributions to Gibraltar.

4. New Initiatives

- Successfully opened the Gibraltar Natural History Museum at Parson's Lodge.
- o Placed gun carriages at Grand Battery to create a Gun Park showcasing cannons from different eras, complemented by interpretation materials.
- Created a virtual tour of Nuns' Well, including accessible and landscaped areas.

5. Policy and Legislation

- Worked on creating a **Language Act** to further protect Gibraltar's languages and intangible heritage.
- Continued populating the Register of Historic Buildings to enhance information and improve public services.
- Actively working on designating the Northern Defences as a Scheduled Archaeological Area.
- Developing measures to protect additional historical assets, such as the Spanish Round Tower at Line Wall.
- o Collaborating on the creation of a new **Development Plan** to integrate heritage protection with urban planning.

6. Licensing

- o Granted 15 heritage licences for works on listed sites, with only two requiring extensions due to delays.
- Issued 24 metal-detecting licences, marking the first instance of such licensing in Gibraltar.

Ongoing and Upcoming Projects

The Ministry is actively working on several initiatives to further enhance Gibraltar's heritage:

- 1. Finalizing a location for the **9.2-inch gun barrel, carriage, and pedestal**, dismantled from Levant Battery and left in a scrapyard for over 50 years.
- 2. Completing the restoration of the Convent Main Façade.
- 3. Commencing the restoration of Landport Gates and Tunnels.
- 4. Recreating the **17th Century Gibraltar Rock Model**, currently held at the Naval Museum in Madrid.
- 5. Planning additional restoration projects for the next financial year.

Collaborative Efforts

The HAAC continues to work closely with stakeholders, NGOs, and private developers to ensure that heritage preservation aligns with Gibraltar's development needs. Round-robin emails were used effectively for decision-making on heritage licences, streamlining the process.

The Ministry for Heritage and HAAC's steadfast commitment to preserving Gibraltar's tangible and intangible heritage highlights the importance of collaboration, community engagement, and forward-thinking initiatives in shaping Gibraltar's cultural landscape.
