**GOVERNMENT MOTIONS**

**The Hon The Chief Minister**

"THIS HOUSE:

RECALLS that the Gibraltar Constitution of 2006 was adopted ten years ago;

THAT the said Constitution of 2006 furthermore, it had its origins in a process which commenced in 1999;

(i)

CONSIDERS that there should be a review of the 2006 Constitution by a Select Committee of this Parliament in order to assess what changes to it are necessary or desirable;

AND THEREFORE HEREBY RESOLVES to establish a Select Committee which shall be known as the Select Committee on Constitutional Reform which shall consist of three Members nominated by the Chief Minister and two Members nominated by the Leader of the Opposition."

"THIS HOUSE:

RECALLS that a Select Committee on the Implementation of the Recommendations of the Independent Commission on Democratic and Parliamentary Reform (known as the Select Committee on Parliamentary Reform) was established by Motion of this Parliament on 4 June 2013;

(ii)

NOTES that the said Select Committee was composed of three Members nominated by the Chief Minister and two Members nominated by the Leader of the Opposition;

RESOLVES that a new Select Committee with the same terms of reference should be established that that it should continue its work seamlessly from the point where the Select Committee established on 4 June 2013 left off;

HEREBY approves the appointment of The Hon Fabian Picardo MP QC (Chairman), The Hon Dr Joseph Garcia MP, The Hon Neil Costa MP, The Hon Daniel Feetham MP and The Hon Elliott Philips MP to the Select Committee."
